### **Sub-theme 4.1: Society, Culture, Tourism and Development**

Development and change research that address fundamental/theoretical as well as applied questions related to development and socio-cultural change is crucial for contemporary Ethiopia. Research on socio-cultural dynamics, and tourism development that result change are essential for the region. It is also vital to figure out the various interacting and mutually dependent fields. Accordingly, the following research areas focusing on society, culture tourism development and media are selected as top priority areas under subtheme I for 2024/25 Call for Proposals:
